All outbuildings and accessory uses must be approved by the developer or its designee. The Developer, or its designee, must approve all building materials and color combinations(including exterior color) and must approve all construction plans in writing prior to the erection or alteration of any existing outbuilding. The developer or its designee, may take action to comply with the terms of this paragraph and shall be reimbursed by the HOMEOWNER for the expenses incurred with complying with this paragraph.

NUMBER 23. <u>DEVELOPER'S RIGHT TO DETERMINE DESIGNEE:</u>
The Developer reserves the right to determine when it will designate the Nautical Chase Homeowner Association to become its designee for the purpose of interpreting these restrictions. This designation, from the Developer, must be granted <u>only in writing</u>, signed by the Developer, and filed of record on the office of the Anderson County Clerk. Otherwise the Developer retains the right to interpret and alter these restrictions, which interpretation shall be binding on all parties.
